2020 COMMERCIAL EXHIBITS DIVISION RULES

1. Set up date and time for vendors will begin at 1 pm on Tuesday, the week of the show. All booths need to be in place by 10 am Wednesday morning of the show. Contact the Commercial Exhibit Superintendent for special arrangements.
2. **All Commercial Exhibit Booths will be open for a minimum of the following hours: Wednesday 11 a.m. - 8 p.m. , Thursday 9 a.m. - 9 p.m., Friday 10 am - 5 p.m., and Saturday 10 am – 6 p.m. PLEASE NOTE THAT START AND END TIMES ARE SUBJECT TO CHANGE. All displays must be removed from the show grounds by 10 p.m. on Saturday evening, unless otherwise approved by the commercial exhibit superintendent.**  
**(Note: The Special Show starts at 8:30 a.m. on Wednesday. If vendors would like to open their booths earlier than 11:00 a.m. on Wednesday morning, you may do so.)**
3. The San Patricio/Aransas County A&H Show shall under no circumstances be liable for any loss, damage, or injury to any person, animal, article, or equipment.
4. Exhibit or concession space may not be transferred or any portion of it sub-let to another party without the consent of the Show Board.
5. The Show Board has the right to cancel the contract of any commercial exhibitor or concessionaires if, the manner of conducting their business is objectionable, or is not as presented in their approved contract. The Show Board may also have all property removed from the show grounds. Any sales or giveaway item that are determined by the Show Board to be contrary to the best interests of the youth of San Patricio/Aransas Counties or disruptive to exhibit animals may be removed from sale or giveaway. The removal of only one of a series of items will not cause the Cancellation of the contract.
6. All improvements on said space shall be done at the expense of the exhibitor or concessionaire subject to the approval of the superintendent. Unless otherwise provided for, all improvements must be removed at the conclusion of the show at the expense of the exhibitors, or concessionaires and the space must be left in a condition equal to that at the time of occupancy.
7. No holes or other excavations shall be made on said space.
8. It will be the responsibility of the concessionaire to comply with Federal, State, County and City regulations governing their operations.
9. Only a certain number of like vendors will be accepted, excluding food vendors. Only merchandise listed on application will be allowed to be sold at said booth. Any unauthorized merchandise will be removed. The type of merchandise will be limited upon the discretion of the Commercial Exhibits Superintendent.
10. All booths in center of exhibit hall will be supplied with 110V power. Displays, tables, etc. will be supplied by the vendor.
